Recruiting materials: adjutant to check with Department before ordering. Fireworks: Merlin Kay reported delivery on June 19, baseball team to help unload, setup on days following, sales begin Sunday June 25.

Department Convention: Younes Convention Center, Kearney; June 22 Exec. Committee meets; June 23-25 general sessions for Legion, SAL, Riders, Auxiliary. Post delegates: Post and SAL commanders, 1 delegate and 3 alternates unfilled. Motion by Jim Cheek and second by Glenn Turner to approve delegates; passed.

Resolutions passed at convention: 1-23 reduce publication of NE Legionnaire newspaper and monthly newsletter from 8 to 6 times/year to reduce costs; 2-23 Department supports Men's College Baseball World Series and is 1 of 8 team hosts, costs \$4,500, ask National Legion to budget for this advertising expense.

Advertise in Convention Program: Ad with payment due at Department by June 9th. Costs: 1/8 pg \$10, 1/4 pg \$20, 1/2 pg \$30; Full pg \$60.

Convention Notes: NE Membership: 77,000; Be the One race car: worth \$50 million in advertising; next National Commander: Dan Seehafer of Wisconsin replacing Jim Troiloa; NE Finances: \$55,061 deficit, 15% decrease in portfolio, expect a dues increase; multi-year memberships: pilot program planned; Dept. Charters Suspended: Colorado and Washington for violating National Constitution, both must resolve issues and reapply; 2023 Membership early bird award: 5 winners, \$200 each; Dept Veteran Service Officer, Levi Bennet: over 14,000 claims submitted by NE's 83 VSO's, free

dental clinic at Mead October 6&7, must pre-register, county VSO required by NE statute so county board cannot eliminate position or its funding; Covid-19 discharge for rejecting jab: see VSO to get upgrade from less than honorable to honorable; **Dept Election**: Commander: John Henry Pearcy, Senior Vice Commander: Carl Lorenzen; Vice Commanders: Area A: Robert "Bud" Neel, Area B: Don Patrice, Area C: Brenndan Moore, Area D: Judy Walters; Auxiliary President: Amanda Washburn; SAL Detachment Officers: Commander: Eldon Kramer, Senior Vice Commander: Tim Heckey, Vice Commanders: East Area: James Keyes, West Area: Case Walton. 2023 National Convention: August 26-31, Charlotte NC, delegate: Les Brauer.

Post Officers Election: In 2020 there was a 2 X 2 motion, officers elected for 2 year terms and allowed to serve 2 consecutive terms in office. While a good idea, there is a misunderstanding about that motion. By the 2021 election, members were informed that the motion was improper and it violated the Department and National Constitutions which say officers are elected for 1 year terms. Therefore, it was void so we had a 2021 election. We also had a 2022 election; both resulted in 1 year terms for officers. So our 2023 election is for 1 year terms.
